eConsignments, Consignee, accepts the items listed on the attached inventory for sale on eBay to the highest bidder under the terms and conditions listed in this contract and the documents attached hereto.

Consignor warrants that he or she is the legal sole owner of the property to be sold. (If property is jointly owned with another person, both persons will have to sign.) Consignor further warrants the description of the item is true and correct as far as he or she knows.

Consignor agrees to the fee schedule that is attached hereto, and part of this contract. Any special fee agreements or changes must be in writing and initialed by both parties.

Consignor agrees to leave the items with eConsignments for a period of at least 20 days during which time they will be listed on eBay for a seven or ten day period for sale. Once an item is listed on eBay, it will run the full auction course until it is sold to the highest bidder. If consignor demands return of the property prior to the end of an auction, or the 20-day period, they will pay a withdrawal fee of \$50 per item. Consignor may not withdraw an item after it is sold, or within the last 24 hours of the auction under any circumstances.

The Consignor also agrees not to bid on auctions that eConsignments has listed for them on eBay. If such an instance occurs the Consignor agrees to pay all fees and commission associated with that auction (if the Consignor is the high bidder), plus a \$20.00 fine and accepts the possibility of not being able to use the auction services of eConsignments in the future.

eConsignments will do everything possible to secure the safety of the Consignor's item(s), however, the Seller is not responsible for any damage of the item, including fire, theft, flood, accidental damage or breakage, and acts of God. The Consignor releases eConsignments of any such responsibility for any unforeseen or accidental damage.

The Consignor authorizes eConsignments to represent the Consignor’s best interest in all correspondence with prospective buyers for all items.

Once an auction has ended with a successful sale, the property may not be withdrawn and will be delivered to the highest bidder once payment is received.

If consignor’s property fails to sell within the 20-day period, consignor agrees to pick up the item or we will arrange to deliver it within ten business days or pay actually shipping and handling charges to have the item returned. Otherwise unsold items will be donated to a local charity.

All items are sold without a Reserve Selling Price unless the consignor agrees to upgrade to the selling service package.

Once an auction is completed and payment is received, the merchandise will be shipped to the buyer. Upon safe receipt by the buyer, EConsignments will effect payment of proceeds, less fees to the Consignor, if a buyer rejects an item of merchandise due to misrepresentation, payment will be refunded to the buyer and the item of merchandise will be returned to the Consignor.

The Consignor has read and understands all statements included in this agreement. This agreement is signed in, and will be interpreted in and subject to the rules of contract of the State of New York.
